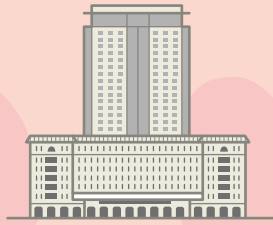

人力車觀光巴士 - 小童八達通免費乘車優惠 條款及細則

1. 優惠期由 2018 年 3 月 30 日至 5 月 6 日。
